### Papers speak

A minister is concerned about collecting funds for the ensuing elections. He expected that he would be able to arrange enough money before the polls. Accordingly, he made a proposal and sent it to the ACS of his department. The officer's disagreement with him over the proposal threw cold water on his fund-collection plans. Now, the minister does not know how to collect such a huge amount of money as is required for fighting an election. In fact, the minister has no importance in the department. Everything happens according to the wishes of the ACS. Whenever the minister asks for any work, the ACS mentions the names of such senior RSS and BJP leaders that the minister does not dare utter a single word. The minister has become financially so weak that he may need to borrow money to fight the ensuing elections. The people close to him say that if he loses the election this time, his political career will end.

### On voyage

A principal secretary (PS) on a constitutional post is on foreign tour these days. His wife is also with him. The conference the PS was to attend was in Canada, but the aim of the officer was to meet his son. After the conference, he went to his son for a week. According to government rules, if a conference continues for six days, the leave period for it is treated as three days, but, for the PS, there is no compulsion to follow the rules. He employs his own rules in department he works for. However, the most important part of his tour is that he is bearing all the expenses of his wife. Both of them work in the same department that recently saw several controversies. After that, the officer has gone on foreign tour to relax. Since his family is associated with politics, he is keeping an eye on the upcoming elections.

# Road mishaps can be averted with sensible driving, claim authorities

Dial 100 data (see tables) shows that number of road accidents is on the rise in MP. The big question facing authorities and people is to identify the real problem in that if it is the good roads or the bad driving habits which leads to more accidents.

ASP traffic Arvind Dubey said, "It is irrational to blame the good roads for the if students are versed in traffic rules and nuances of driving, they will not just become perfect drivers but also better navigation aid to the elders who drive them around."

He added "It is high time that a course on driving and traffic rules should be introduced in the school curriculum and passing it should be made mandatory."

Roads in MP, which were once considered bad, are now being compared with those in Washington.

Chief engineer of the public works department Akhilesh Upadhaya claimed that between 2003

and 2018 not just the length of roads but importantly the maintenance and renovations of the roads too has improved.

He told Free Press that the length of district main roads had increased from 11,051 kilometres (km) to 22,129 kilometres and the length of national highways have increased from 47.22 km to 11,822 km.

Upadhaya said that the fund for maintenance has increased from Rs 30 crore to Rs 710 crore in 2018.

He claimed that the government is trying to build better roads in MP, and about accidents he said, "Roads are constructed ac-

ording to best practices of road engineering."

Dubey too second his opinion, "It is irrational to blame the good roads for the accidents. The pressure of vehicles, on the roads, is increasing by the day."

He added that along with heavy traffic, rash driving, lack of patience and use of mobile while driving too are the reasons for increased accidents.

"Importantly the drivers lack civic sense, they violate traffic rules at will including over speeding."

He added "Better roads give the opportunity to the drivers to run the vehicles

# RaGa's road show today, workers all geared up

Party expects participation of over 2 lakh

Congress workers of the State are all geared up to welcome the party president who will lead a road show here on Monday. Congress banners, posters, party leaders cut outs have been put up in the entire city to welcome the party president. Posters and hoardings of party leaders have also been put up by their respective supporters. This is the first visit of Gandhi to the state capital after the appointment of Kamal Nath as party state president. The visit of



Gandhi will boost the morale of party workers in the poll-bound state. In a bid to show its strength, directions were issued to party workers to come in large numbers. The party aims to gather around 2 lakh supporters in the road show to give a big challenge to the ruling BJP. Every district

president has been directed to bring 5000 supporters from their respective areas for the road show.

Similarly, the party ticket aspirants have also been asked to come with same number of supporters from their constituencies. The police and the district administration have chalked out detail plan for the proposed rally; SPG has taken over the security arrangements.

The rally will start from Lalghati at 1 pm and will reach BHEL Dussehra Maidan around 4 pm. Party president will address the public at Moti Masjid, Roshanpura square and Board office square. He would meet and address selected 15,000 Congressmen at BHEL Dussehra Maidan.

## Traffic diversions, restrictions in place

Widespread traffic restrictions would be in place across the city in wake of Congress president Rahul Gandhi's road show here on Monday.
